Case # 1639-2022

ISSUE 1: Whether the appeal was timely filed or whether the appellant has good cause for untimely filing the appeal as provided in *Montana Code Annotated* § 39-51-2403. (38 days late to UIAB).

ISSUE 2: Whether the appeal was timely filed or whether the appellant has good cause to delay filing the appeal as provided in *Montana Code Annotated* § 39-51-2402(3). (13 days late to OAH).

ISSUE 3: Whether the claimant is qualified to receive Pandemic Unemployment Assistance (PUA) benefits under Section 2102 of the CARES Act of 2020, Public Law 116-136.

ISSUE 2: Whether the claimant established good cause to backdate his claim as provided in *Montana Code Annotated* § 39-51-2104(1) (a) and Administrative Rules Montana 24.11.445(5).

ISSUE: Whether the claimant is ineligible to receive benefits because of a failure to provide information requested by the department and necessary to determine the eligibility of the claim, in accordance with *Montana Code Annotated* § 39-51-2104 and Administrative Rules Montana 24.11.452A.
