New UI System Go-Live, October 2, 2023

It's finally here! The yearlong modernization and integration of our Unemployment Insurance (UI) systems is nearing completion. The new system will go-live October 2, 2023.

To allow time for conversion and cut over, **all Unemployment** Insurance Division (UID) systems, including <u>UI eServices for</u> <u>Employers</u>, will be unavailable starting at 5:00pm (mountain time) on Thursday September 28th through October 1, 2023.

The new Montana Unemployment Services Enterprise (MUSE) system will integrate both UI Contributions (tax) and Benefit Claims functions into one unified IT system. MUSE will allow us to streamline processes and improve efficiencies across the division and UI program.

Employer and Third-Party Administrators (TPA) will benefit from a mobile friendly redesign of <u>UI eServices for Employers</u> that includes:

- An OKTA single sign-on,
- Built in options for responding to requests for Separation information on benefit claims,
- Expanded secure web messaging features,
- Improved options for managing your tax account, and
- All the same great tools for filing and paying quarterly UI reports and contributions.

The responsive nature of the redesign will allow <u>UI eServices</u> for <u>Employers</u> to be accessed from any mobile device or tablet. The expanded messaging and fact-finding features will provide early access to claim issues or requests for information.

What's not changing? The web address for UI eServices for Employers will remain the same, <u>uieservices.mt.gov</u>, as will all our bulk filing and rate exchange file formats. For TPAs who utilize our server-to-server web service file exchange, the end point and your credentials will remain the same as well.

Accessing UI eServices for Employers On or After 10/2/23

Included with the redesign of <u>UI eServices for Employers</u> is a new way to log in, using Okta.

As the State of Montana moves towards a goal of single sign-on access to state services, Okta is the access management software being used to authenticate users. Think of it as the doorway into <u>UI eServices for Employers</u>, and other State of Montana services.

Returning UI eServices for Employers Users

If you have used eServices in the past, access after October 2nd, is a matter of connecting your existing eServices logon creditials with an Okta account:

- Go to uieservices.mt.gov
- Click "Sign In with Okta"
- If you have an existing Okta logon, enter your creditials. If not, you'll need to create an Okta account
- Once you have signed into Okta, you will be redirected back to UI eServices for Employers to enter your current eServices username and password

Once you have connected your Okta account to eServices, you'll no longer need your existing eServices credintials, you will log in using your Okta username and password.

New to UI eServices for Employers

For existing employers who are new to eServices, the intial login process will be similar, except you will need to answer a few security questions about your UI tax account to verify your identity and create an eServices profile. It may be helpful to have the last quarterly report filed for your business on hand to answer the questions.

New Employers

New employers who have not yet registered with Montana Unemployment Insurance, will need to select Sign Up for eServices from <u>uieservices.mt.gov</u>, log into Okta, and then create a UI eServices for Employers profile before completing a New Employer Registration.

The sessions for Employers and Third-Party Administrators (TPA) will be similar but TPA sessions will add more focus on how you can connect and interact within the system on behalf of your clients.

- Navigating the new design; managing your profile, filing reports, making payments and more,
- New and improved tools for communicating with UID, including additional options for responding to requests for information regarding benefit claims.
- For TPAs: all the above, plus submitting bulk files and authorizations forms, connecting clients, and managing access for your staff.

2024 Taxable Wage Base

The 2024 taxable wage base will be \$43,000 which is 80% of the 2022 average annual wage (\$53,793), rounded to the nearest \$100.

We recommend you do not update payroll software with the 2024 taxable wage base until AFTER you file the UI report for the fourth quarter of 2023.

Discontinuing FAX Communications

With our efforts to streamline processes and improve security, the Unemployment Insurance Division (UID) will be discontinuing the use of FAX machines in October 2023 and encourage the use of our online portals for <u>employers</u> and claimants to securely transmit information to our office.
